#### Overview

This index strategy:

- Combines lower-risk short-term interest-rate sensitive assets with higher-risk real assets with medium- and longer-term inflation protection characteristics to constrain risk


## THE THEORY

In addition to inflation-linked bonds, real assets can provide additional layer of inflation protection (Amenc, Martellini & Zieman, 2010). Incorporation of real assets exposure requires trade-offs between inflation sensitivity, reliability, and risk-adjusted returns (Childers, 2011). Correlations between inflation-protective asset classes and inflation vary and depend on investment horizon, meaning different asset classes have different inflation-protective qualities over different terms (Briere & Signori 2011).

## **1.** INCREASE DIVERSIFICATION

The index represents a range of real asset exposures that focus on providing a real income, a real value or a real difference.



## 2. PROTECT AGAINST INFLATION


The index provides access to key exposures that enable a layered approach to inflation protection over different time-frames.
